Introduction

The Index of Industrial Production (IIP) is an abstract number, the magnitude of which represents the status of production in the industrial sector for a given period of time. The IIP describes changes of the volume of goods and services produced over time. Its main purpose is to provide a measure of the short-term changes in the volume of industrial production from the manufacturing sector in the country. The major advantage of the production index compared to other indicators is the combination of fast availability and detailed breakdown of activities.

Monthly IIP is computed on provisional basis and the index is revised annually. The revision of monthly index of 2016 is released with the provisional IIP for the month of January 2017.

Since January 2017 the index will carry point to point changes, that is, 2017 January production is compared with the 2016 January production for measuring the changes in industrial production volume.

Index of Industrial Production (IIP) Jan 2016 – Jan 2017

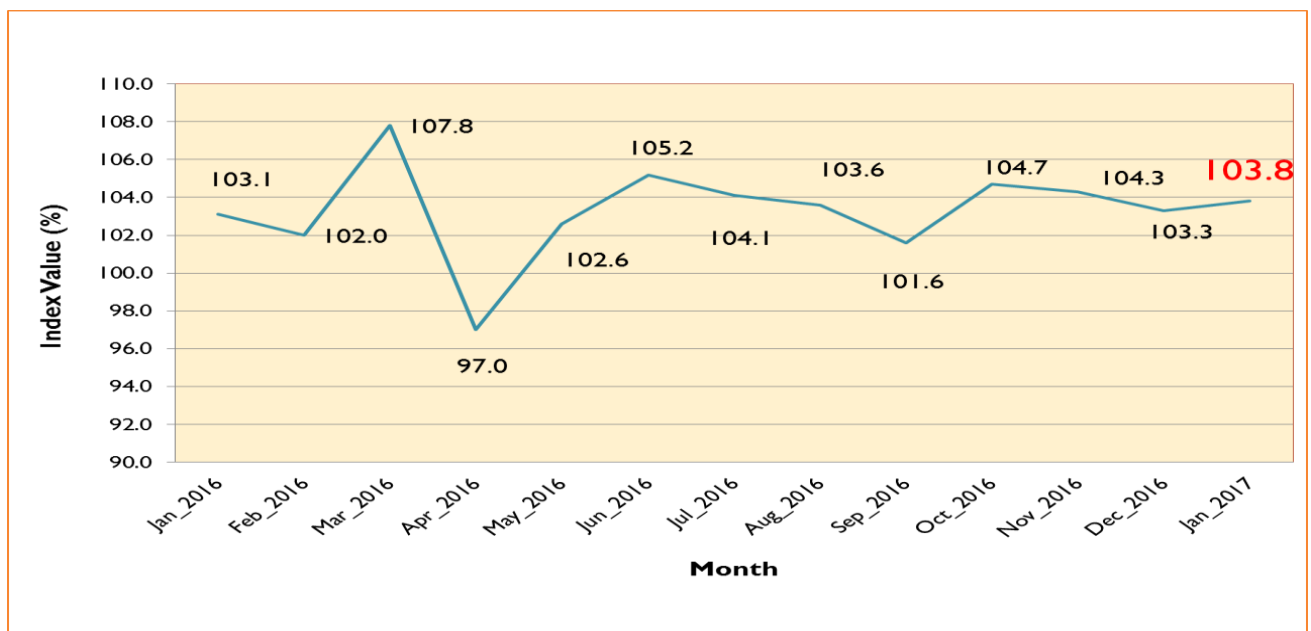
